WAIVER AND RELEASE OF LIABILITY

In consideration of Ronald McDonald House Charities and Spitzie's Harley Davidson furnishing services to enable me to participate in the Ronald McDonald House Charity Ride, I agree as follows:

I fully understand and acknowledge that: (a) risks and dangers exist in my use of motorcycles and motorcycle equipment and my participation in the Ronald McDonald House Charity Ride (b) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability, (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Spitzie's Harley Davidson, Ronald McDonald House Charity, the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes.

These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/ or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of Ronald McDonald House Charities, Spitzie's Harley Davidson, or by any other person. By bringing my own or any other motorcycle, I also agree that this release applies to any damage that occurs to it during the Ride.
