As a means of expanding our compassionate support to families recently touched by serious childhood illness the Ronald McDonald Family Retreat offers a peaceful, supportive setting where families can enjoy being together as a family, making lasting memories. The Family Retreat, a private cottage located in the heart of beautiful Lake George village, feels a world away from the hospital. It is just a short walk to village attractions, shops, and the beach.

A stay at the Ronald McDonald Family Retreat during the summer/fall season of 2021 will provide your family with a five day, four night accommodation at the Family Retreat. Each stay is offered from Saturday morning to Wednesday evening to a single family, and sleeps up to six individuals. The two story, two bedroom cottage offers all the comforts of home.

### 1<sup>st</sup> Floor:

- Cozy Front Porch
- Warm foyer with fireplace and window seat overlooking the front porch
- Relaxing family room with comfortable furniture, tv, books and games
- Full kitchen with seating for 8
- Full bathroom with an accessible shower
- 1<sup>st</sup> bedroom furnished with a queen and twin bed

### 2<sup>nd</sup> Floor:

- 2<sup>nd</sup> bedroom furnished with a queen and twin bed
- Full bathroom with bathtub
- Washer and Dryer

Additionally there is a lovely back garden area with a picnic table and deck for your use. Other fun conveniences provided on site include bicycles, a wagon and beach toys. Along with each stay, Family Retreat guest families will receive a complimentary welcome bag and services from Lake George community business partners, all at no cost to you.

To provide compassionate support, assistance and niceties, an RMHC Host will be available for check in and onsite, in other private quarters, during your stay for your convenience as needed.
